-	Right here in Travis County, our criminal justice system is broken. In the most progressive county in the state, our criminal justice system weighs most heavily on working class people, people of color, and the LGBTQIA+ community. Within the LGBTQIA+ community, our criminal justice system weighs most heavily on LGBTQIA+ people of color. Nationally, for example, 85% of LGBTQIA+ youth in juvenile justice facilities are youth of color. In addition, according to research produced by the Center for American Policy, LGBTQIA+ immigrants of color are at increased risk of interaction with the criminal justice system and the immigration enforcement system. Here in Austin this past September, Austin Independent School District (AISD) Police opened an investigation into Naomi Wilson, a local transgendered black woman. They began investigating her because she spoke up when she was harassed and bullied during an AISD board meeting. When the LGBTQIA+ community rallied in support of Naomi, I was honored to be invited to participate in a press conference to speak out against AISD Police conduct. I was proud to stand by Naomi and demand that she and all of LGBTQIA+ community be treated with dignity and respect by local law enforcement. In addition, as the Executive Director of Workers Defense and during my time as an assistant federal public defender, I have consistently advocated on behalf of members of LGBTQIA+ community fleeing persecution in their home countries. I would be honored to partner with Stonewall to create a criminal justice system in Travis County that works for everyone.
Erin Martinson	I have worked with victims of violent crime for the entirety of my career. As such, I have represented many LGBTQIA clients in court, helping them secure protective orders to keep them safe. I have managed two programs aimed at assisting crime victims and, in both organizations, I created policies that were friendly to LGBTQIA folks. When I worked for Texas Legal Services Center, we conducted outreach specific to the LGBTQIA community to ensure they were aware of our services. I've marched in Pride parades alongside my LGBTQIA neighbors and have attended public awareness events such as Intersex Awareness Day at City Hall. I am seeking your endorsement because you are my favorite club in Austin and I am committed to ensuring that those who identify as LGBTQIA feel safe in our community.
Margaret Moore	I value the message this endorsement would send to voters. I do have a history of support. I serve on the Austin/Travis County Hate Crimes Task Force. We joined APD in promoting its "Safe Place" program to help victims of anti-LGBTQIA+ crimes. I have two prosecutors who handle all hate crime investigations, which enables them to specialize in the issues surrounding these cases. They are consulted by law enforcement when a suspected hate crime occurs. We are currently prosecuting a hate crime case that involves an assault on a gay couple.

	Stonewall Democrats commitment to fairness and justice is well-known; I would be proud to have your endorsement. Yes, I have a long history of publicly supporting LGBTQIA+ issues. More than 25 years ago, as a volunteer at the Austin Rape Crisis Center, I responded to calls to assist survivors of same sex assault. In one case, I was in the hospital room with a victim who was reluctant to have women in the room; his trauma and anguish and the trauma for his family is unforgettable. When I opened the Domestic Violence court I ensured that same sex couples were issued protective orders - at that time, many states and counties refused to include same sex couples in these courts. After the Obergefell decision, I was one of the first judges to conduct weddings and continue to do sol As lead prosecutor (CA) I pushed law enforcement to report and file hate crimes. In Phoenix court, I made sure that this program is available to everyone, helping prevent criminal records.
Laurie Eiserloh	I have 27 years' experience as a trial lawyer and 30 years as an LGBTQIA+ advocate. I will fight Trump, Abbott, Paxton or anyone who tries to harm us. The County Attorney has been a local leader in protecting and advancing the rights of LGBTQAI+ since the early 1990's when it helped establish Domestic Partner benefits and a registry at the height of the AIDS crises. When AG Abbott attempted to take those benefits in 2013, I was a leader on the County legal team that fought back. When people are denied employment, housing, and public accommodations because of discrimination, that creates more instability for families and communities and that makes all of us less safe. LGBTQIA+ people of color are overrepresented nationally in our criminal justice system because of a variety of factors. They are pushed into our criminal justice system by unsafe schools; family rejection; and poverty, unemployment, and discrimination. I have spent my entire career - as a public defender, at the National Labor Relations Board, at the Department of Labor, and as the Executive Director of Workers Defense Project - fighting side by side with working people in order to help foster stability for families and communities. I would advocate for a state law that would prohibit discrimination in employment, housing, and public accommodations based on sexual orientation and gender identity or expression because it is the right thing to do and because it will foster stability and keep our community safe.
Erin Martinson	Absolutely. Housing, employment and public benefits are basic human rights that should be available to everyone, regardless of their status.
Margaret Moore	Yes. In this Office, we follow that policy now, but I believe it is important for this State to formally prohibit discrimination.

Mike Denton	Yes, of course. This is fundamental fairness - there is no other justification needed.
Laurie Eiserloh	Yes, I fully support. Travis County is pioneer in granting full benefits to employees starting with DP benefits in the 1990's and more recently paying for gender reassignment surgery and hormone therapy for its employees. Dominic Selvera	I would support such a state law because discrimination based on sexual orientation, gender identity, and expression is wrong. We need strong anti-discrimination legislation in Texas that protects the LGBTQIA+ community.

Liz Donegan	Absolutely. I know from my work in the sexual assault space, that this "issue" is made up and is nothing more than hateful, fear-mongering rhetoric pushed by the right. I was contacted by the first state (North Carolina) as an expert in relation to alleged sex assaults (in bathrooms) by members of the trans community. Which I vehemently opposed the notion being put forth based on the evidence of my expertise.
Sally Hernandez	Yes, while it was a major victory that the U.S. Supreme Court affirmed the constitutional right to marry, we must continue to change the many other aspects in which the LGBTQIA+ community experiences disparity and discrimination. This is especially true here in Texas where the Texas Supreme Court ruled that LGBTQIA+ couples are not entitled to benefits.

I support compensation transparency, across-the-board pay increases when possible, collective bargaining agreements, and policies that prohibit compensation discrimination on the basis of sexual orientation and gender identity or expression in order to ensure fairness in matters of compensation.
Erin Martinson	No, I do not. When I am elected, I will continue to fight for the rights of everyone in our community. I will create equitable policies so that employees of the DA's office do not feel discriminated against because of their sexual orientation, gender identity or expression.
Margaret Moore	No. I support Travis County's commitment to providing these benefits.

Mike Denton	The Texas Supreme Court got it wrongl As CA, I would advise the Commissioners' Court that same sex couples should receive the exact same employee benefits as straight employees. If required, the County should consider filing suit to force the issue again.
Laurie Eiserloh	I do not agree with that decision. Now the U.S. Supreme Court is considering whether Title VII (law that prohibits employment discrimination) applies to LGBTQI+ people. If the Supreme Court rules in the negative, my fear is that Governor Abbott and AG Paxton will use this ruling against our community. If that happens, as the Travis County Attorney, I will use my vast experience as a litigator and LGBTQI+ advocate to protect Travis County employees and to set a beacon for other employers in Texas.

Delia Garza	No, like the attorney representing the City of Houston, I agree that "Equal recognition of same-sex marriage requires more than a marriage license; it requires equal access to the constellation of benefits that the state has linked to marriage." If elected I would work with the human resources staff to ensure that we are surveying employees regularly to understand and address any concerns about unfair compensation from all employees.
	I do not agree with the decision from the Texas Supreme Court that discriminated against same-sex couples and deprived them of benefits that they deserved. As Travis County Attorney, I would be a public advocate to end this discrimination and publicly call out and shame any company that discriminated on this basis. Valinda Bolton	I do not agree with the decision. I am already planning a push to secure guarantees on wages, working conditions and terms of work for all county employees and contractors. We can extend that to entities that enter into a service agreement with the county as well. While making sure that a high standard of protection for workers is in place I will specifically enumerate that there be equity based on sexual orientation and gender identity built into all contracts. We can set a standard thus.

Ann Howard	No, I do not agree with the Court's decision. I believe that benefits based on marriage extend to all married couples. As a County Commissioner, within my first 100 days, I would ask the County HR Department and AFSCME for briefings on HR policies to understand more fully how the County handles these benefits and if there are any policy gaps that need to be corrected. Question 8	If elected, what concrete actions would you take to support the Intersex
	community?
District Attorney	
-	For too long, the Intersex community was not acknowledged in Austin and issues that impact that community were not addressed. Because of the advocacy of Stonewall members and others, the City of Austin has taken some steps to recognize the harm that the intersex community sometimes faces - such as unwanted medical procedures. The primary responsibility of the District Attorney is to keep our community safe. I have learned a tremendous amount from advocates and when I am elected, I will continue to listen to advocates to learn how best the District Attorney's office can keep all of our community - including the Intersex community - safe.
Erin Martinson	I will continue to show up for and advocate for the rights of intersex individuals and I will support legislation that prohibits doctors from performing surgeries on children before they are able to consent.
Margaret Moore	The same actions I've already taken to prosecute cases without regard to sexual orientation, gender identity or expression. We also do not discriminate on that bases in our employment decisions.
County Attorney	
	The Intersex community needs proactive support. Unfortunately, the stigma and actual danger for people in this group begins at birth. From the legal system perspective, it is necessary to understand how the system is failing the Intersex community now in order to craft specific and effective changes. Beyond the legal system, we must include Child Protective Services, foster care and medical professionals to find solutions. I would be happy to participate in this process.
Laurie Eiserloh	I will strongly advocate against: (1) so-called "gender normalizing" surgeries until a person is old enough to make their own decision about whether to have the procedure; and (2) TX law requiring male/female only after a gender change. I will advocate for change to Travis County HR documents to include nonbinary gender descriptions. I will immediately change County Attorney domestic violence intake forms which currently allow gender binary terms only.
Delia Garza	I would create a policy in County Attorney's office that requires the use of proper pronouns and preferred names for victims and defendants. I would also work with our social service community to create appropriate counseling for the Intersex victims of domestic abuse. Furthermore, when incarcerated, the transgender, intersex, and gender nonconforming community need to be given proper facilities that do not place them in danger. I would work with the sheriff's office to ensure safety in our jails.

Dominic Selvera	I would fight to make sure that intersex folks are not discriminated against based on how they identify sexually. I would also make sure that people's preferred pronouns are respected and adhered to in our office.

	I would advocate for policy changes within TCSO, statewide and nationally. The intersex community should not be shamed nor kept in the shadows. First responders, investigators and corrections officers will be trained to be sensitive to the needs of the community. I will create practice and policy and ensure they are acted upon to meet the needs of the community. PREA (prison rape elimination act) committee at TCSO should have a representation from the intersex and trans community.
Sally Hernandez	As your Sheriff, I believe in partnership and building bridges. I want to put a spotlight on issues and work together to move the ball forward. I am willing to work with groups and any community members to better train my officers to interact with people from different backgrounds. As Sheriff, I have worked to ensure that anyone who is booke into the correctional facility is safe and placed into the facility that they are most comfortable in.

Bruce Elfant	I have supported the Intersex community and will continue to take part in efforts to support their full inclusion in Travis County. There will be no discrimination of Intersex applicants, employees or customers in the Travis County Tax Office.

Jeffrey Travillion	I support raising awareness of Intersex community issues and addressing community priorities. My office is always a meet and address community issues.
Commissioner - PCT 3	
Valinda Bolton	The Travis County clerk's office needs to examine all of the documentation it keeps to make sure that it is inclusive and affirming of all genders, including intersex people. As we push to provide more comprehensive mental and behavioral health for Travis County we need to make sure that county health service providers are trained on sexual health and gender identity. We can also block funding from the County for Intersex surgeries that happen before an age allowing informed consent
Ann Howard	I would start by meeting with members of the Intersex community who could bring me up to speed on local policy issues related to their concerns on a broad spectrum of issues from housing to courts to healthcare. As a progressive Democrat, I am committed to breaking down barriers that hold people back. I'm committed to undoing and eliminating systemic discrimination of all kinds.

Shiloh Newman	The job of Travis County Commissioner focuses mainly on roads, parks and infrastructure. I would look for ways to support your community and happily listen to any ideas you have for ways my position would help most.
Sheri Soltes	Although the county does not have legislative power, I would support efforts to adapt the census to include a category for intersex, to allow intersex individuals equal rights to serve in the military, to oppose so called "corrective surgery" unless it is to resolve a life threatening crisis.
Constable - PCT 1	
Tonya Nixon	The first step would be to get more informed, educated, and involved with the Intersex community. I just started learning more about the Intersex community this year after meeting Alicia Weigel.
Janie Serna	The first thing would be to better educate myself, and that will happen regardless of election outcome. Once elected, I'd start with a dialogue involving local (and some less local) legislators - discussing intersex human rights issues.
Constable - PCT 2	
Adan Ballesteros	I am just becoming aware of the term and feel we as a society should review the policies of the medical community and determine the right course of action that takes into account the desires of the individual. I would support any future legislation that advocates for members of the Intersex community.
Constable - PCT 4	
George Morales	I will continue, as a Constable, to make sure that the intersex community has their rights and safety protected. I will advocate for laws that increases their rights and gets rid of discriminatory practices.

Question 9	Do you think the judicial system is doing everything it can to be sensitive to the rights and dignity of our LGBTQIA citizens?
District Attorney	
Jose Garza	No. In the most progressive county in the state, our criminal justice system weighs most heavily on working class people, people of color, and the LGBTQIA+ community. Within the LGBTQIA+ community, our criminal justice system weighs most heavily on LGBTQIA+ people of color. LGBTQIA+ people of color are overrepresented nationally in our criminal justice system because of a variety of factors. They are pushed into our criminal justice system by unsafe schools; family rejection; and poverty, unemployment, and discrimination. In addition, LGBTQIA+ people of color are disproportionately impacted by discriminatory enforcement of drug laws. Because of high rates of substance use within the LGBTQIA+ community and high rates of drug arrests among people of color, LGBTQIA+ people of color are at greater risk of arrest for drug related offenses. It doesn't have to be this way. We have the power to fix this.
Erin Martinson	No, I do not. I think that even in progressive Travis county, we have some judges with very archaic ideas about marriage, families and relationships. I think many LGBTQIA individuals feel discriminated against in court and I have witnessed this firsthand in court. I think we have a lot of work to do to continue educating the judiciary and continuing to bring cases fighting for the LGBTQIA community. I am excited that for the first time, we have several candidates who identify as LGBTQIA.
Margaret Moore	One initiative I've supported that is yet to be implemented is to adopt policies that would make complaints filed by law enforcement non-gender specific.
County Attorney	
•	While progress has been made, it has not gone far enough. Stigma and discrimination are still common and these biases can be reflected in the behavior of judges, poice and prosecutors. As an instructor for the National Council of Juvenile and Family Court Judges, I have taught all over the country, stressing awareness of LGBTQIA issues and uring Judges to respond with sensitivity and fairness. These changes must also apply to judicial staff, prosecutors and police.
Laurie Eiserloh	While Travis County Judges do better than most for our community, they are constrained by state law and we must advocate for change. We should not have to adopt our own children, we should not be forced into binary gender categories, gender nonconforming detainees in the jail should be housed in the jail population matching their chosen gender. Agree with the 9th Cir. which held that a prison's failure to provide gender reassignment surgery is cruel and unusual.
Delia Garza	No. In addition to the changes I would make referenced above, there should be a position either in the County Attorney or District Attorney's office that could be the point person on LGBTQIA issues. This person could also be in charge of administering continuing legal education to both offices to help educate the legal community on LGBTQIA issues and help train prosecutors (and judges) on working with LGBTQIA victims in a way that is trauma-informed and inclusive.

Dominic Selvera	I do not think the judicial system is doing everything it can to be sensitive to the rights and dignity of the LGBTQIA+ community. One of the major problems is that conservative judges hold anti-LGBT views and allow discrimination to exist. The Texas Supreme Court, 5 th Court of Appeals, and the Supreme Court have a majority of Republicans on the bench and it should be a priority to vote them off the bench in Texas and vote in a Democrat to the White House who will push through progressive judges at the federal level.

Liz Donegan	Absolutely not. Within the judicial system so much more can be done to change the culture, to educate and to advocate for members of the community. Law enforcement should be collaborating with the community on issues that are unique to the community. Inviting the community in to be partners in change in both law enforcement and the jail. Training officers and making changes to policy and procedures in how to appropriately address the trans community. Police reports and probable cause affidavits that use preferred pronouns should be implemented.
Sally Hernandez	No, but not because we are not trying to improve the system but rather because there is always room for improvement. We must always face challenges and learn. Challenges are daunting and won't be completely remedied overnight. Learning is an ongoing process. I don't pretend to know everything, but I do promise to work hard and continue building partnerships and building bridges to ensure that the practices at my office are the best and replicated across this state.

Bruce Elfant	Since many court rulings have struck down efforts to end discrimination I would have to say no.

Jeffrey Travillion	No. We need to continue to raise awareness of issues and build a forum to address problems.

Valinda Bolton	Travis County has many compassionate judges e.g. we have become a common place for Texans to seek gender changes on legal documents. However, the law is stacked against the LGBTQIA+ community in a number of ways. Homosexual panic is an outrageous legal loophole that is being used successfully to defend hate crimes. There have been decisions allowing denial of service to LGBTQIA+ couples by businesses and religious group creating legal precedent for discrimination.

Ann Howard	No. I have strong concerns about federal and state courts inability to understand the rights (or lack thereof) and dignity of our LGBTQIA+ citizens. However, as County Commissioner, my initial focus will be to ensure that our local courts are managed properly to ensure that rights and dignity are respected. This holds true for our overall criminal justice system here in Travis County.
Shiloh Newman	Obviously the judicial system has a history of failing the LGBTQIA community. While changes have been slowly happening, it's clear that very few elected officials are truly trying to make a difference in their lives.
Sheri Soltes	No. This includes the way individuals are housed in correctional facilities. Intersex individuals should be housed in the gender-oriented facility of their choice and be protected from bullying and violence. Further, adoption, military service, right to marry, spousal insurance benefits, right to equal service from businesses.
Constable - PCT 1	
Tonya Nixon	The judicial system plays an important role in the fight for the rights of LGBT citizens. And while great strides have been made in the fight for equal rights in the LGBT community, there is plenty of work still to be done to address LGBT issues.
Janie Serna	There are always improvements that can be made to better ensure inclusivity, fairness, dignity, and respect for citizens in marginalized groups.

Adan Ballesteros Constable - PCT 4	No.
George Morales	We like to think that Travis County does a good job but there are too many LGBTQIA citizens that lack representation and whose rights are not being defended. We need to have a better judicial system that takes care of our LGBTQIA community.
